This exhibition encourages the importance of developing art from the Youth of SA, and provides a chance of exposure in the picturesque RSASA Gallery

### Conditions

Artists are allocated space for two artworks, each not larger than 1m x 1.5m. Works are encouraged to be of gallery standard, ready for hanging, mounted or framed, with 'D' rings. Artwork is to be delivered to the RSASA Gallery, Level 1 Institute Building, corner of Kintore Avenue and North Terrace, Adelaide. Artwork may be rejected if it does not comply with the rules at the discretion of the RSASA Council. RSASA reserves the right not to display any works, for whatever reasons. Artworks can be for sale, a 30% commission applies by RSASA. Works for sale should be priced accordingly, or marked Not for Sale.

Works of art should be original, uncopied and the work of the artist. On the back of each work should be: **Name of artist, age, mediums, art institution or school attending (if relevant).** A separate form requiring names, titles of works, prices, and comments from artists about their works is to be given when works are delivered.

### Size of works:

2D works - max 1m. x 1.5m

3D works - max 870mm x 870mm x 1.5m in height, weight 50kg

Artists awarded relevant artistic awards will be notified. Publication of works: The RSASA may photograph works for publicity or archive records. Responsibility for insurance of artworks remains with the artist. The RSASA will take every care with entries but does not accept any responsibility for any damage or loss. Goods in transit are the exhibitors' responsibility. Safe keeping of all boxes & packing is the responsibility of the exhibitor & must be removed from the venue.
